# Membership Requirements

## MISSION STATEMENT

The purposes for which the Club is organized are: to foster and encourage yachting; to promote and increase the efficiency of its members and others in the science of Navigation and they are of handling and sailing yachts and other vessels; to promote the social interests and pleasures of its members, as a non-profit organization.

## CLUB PURPOSE

SYC is a private club with the principal goal of enhancing safe recreational boating and fellowship in the Sacramento area. We offer many events and facilities to accomplish this. By the nature of our location, most of our boats are power, although some sailboats are to be found. SYC is family-oriented based and is primarily a volunteer Club, meaning that member effort constitutes a large part of the maintenance labor force and for upgrades to our Club.

## REQUIREMENTS FOR MEMBERSHIP

Generally it takes 2-4 months to be inducted into the Sacramento Yacht Club. During that time prospective members are encouraged to participate in as many Club activities as possible.

1. Prior attendance of a minimum of two SYC Events
2. Sponsorship by two members that are in good standing with the Club
3. Payment of Initiation fee of \$250 is required (non-refundable).
4. Approval by Membership Committee and Board of Directors
5. Payment of annual dues: Currently \$505.00 per year (or pro-rated amount)

## PROBATION PERIOD

The first 90 days of your membership at the Sacramento Yacht Club is considered a probationary period. Attendance at Club events, volunteerism and adherence to the Club's Bylaws and Marina Rules will be monitored by Flag Officers, Directors and general membership to assure compliance in each of these areas.

## MARINA USAGE

Sacramento Yacht Club's marina facilities are amongst the best available in the Sacramento Area with dockage available to members that are in good standing, with varying slip lengths and either covered or uncovered berths. Availability is on a first come, first served basis. The Marina is supported largely through volunteer efforts to keep our slip fees extremely affordable. MARINA RULES AND LEASE OF DOCKAGE AGREEMENT

**\*This Rental Rate is subject to your compliance with the Credit Earned System more fully described in the Marina Rules.\***

The SYC Marina was built by the members of the Sacramento Yacht Club to provide a convenient and affordable dockage for access to member vessels, as well as to contribute to the social atmosphere enjoyed by SYC's Members and their guests. Floats, piers, wharfs, fingers, moorage, and island are herein referred to as "docks".

In SYC's endeavors to operate the Marina in a safe and consistent manner for the enjoyment and safety of all and to preserve the Marina's structural quality, Marina Rules have been instituted. These rules are established to provide the operational guidance to accomplish these goals. Failure to observe these rules will be grounds for revocation of Marina rental privileges. The Board of Directors have the sole power to resolve all conflicts regarding a violation or interpretation of the rules herein and may hold hearings to determine whether a rule is ambiguous or extenuating circumstance should be considered. The final decision to remove a member's Marina privileges or resolve any conflict is that of the Board of Directors.

#### Terms and Conditions of Lease of Dockage Agreement:

1. This Agreement is for use of a Mooring Space only for the above-described boat ("Boat"), and such Mooring Space shall be used at the sole risk of Member. SYC shall not be liable for the care or protection of the Boat nor for any loss or damage of whatever kind or nature to the Boat, her contents, gear or equipment, or any other property howsoever occasioned. SYC expressly does not warrant the availability of utility services to Mooring Space, and shall not be responsible for any damage or injury due to the interruption or unavailability of utility services. SYC does not warrant that the utility services will be compatibles with the utility service requirements of the Boat (including electrical interconnection requirements or the effect of electrolytic action).
2. SYC shall have a lien against the Boat, her appurtenances and contents, for any and all unpaid sums due for use of the Mooring Space or for damage caused or contributed to by the Boat or by the Member, its guests, invitees or licensees to any other docks or property of SYC or to any other person at SYC Marina. Lessee agrees to pay any and all costs of collection and reasonable attorney's fees incurred by SYC in connection with or arising out of any and all delinquent sums owed to SYC.
3. This Agreement shall continue in effect from month to month, unless sooner terminated as provided below:
  - a. By destruction of the Mooring Space by fire, storm or any other calamity.
  - b. In the event that the Member shall make a bona fide sale of the Boat, in which event the Member shall immediately notify SYC.
  - c. Upon ten (10) days written notice by SYC to Member terminating the Agreement with or without cause.
  - d. By breach or default by Member as provided in Paragraph (4) below.
4. The first and last month's rent is due at the time a member agrees to rent Mooring Space. Monthly rent is due on the first of each month, and it is paid in advance. Rent is delinquent after the 20th day of the month and will be assessed a 10% penalty per month. Utility payments are due with the rental payment and are based on meter readings taken on or about the 20th of each month. Delinquent utilities payments will be assessed a 10% penalty each month. All other charges arising from Member's use of the SYC Marina are due, owing and payable upon written notice thereof.



5. Members must pay their slip rental and slip utilities by the 20th day of the month invoiced. Slip rental and utility payments outstanding after any two billing cycles or 60 days, whichever period is shorter, shall be in Default of these Marina Rules. If a Member is in Default of these Marina Rules, SYC shall have the following remedies:

- a. SYC may remove the vessel and store or re-dock the vessel at any location in any commercially reasonable manner. Charges for towing, removal and storage shall be at the expense and on the account of Member and charges shall continue until all slip rental and utility payments outstanding are brought current to the satisfaction of (or "as defined by) the SYC Board of Directors;
- b. SYC may "lock" the vessel in place until all the slip rental and utility payments outstanding are brought current to the satisfaction of the SYC Board of Directors;
  - 1) By "locking" the vessel in place, the Member takes full responsibility for any damage to the vessel or any SYC property said action may cause in the pursuit of this remedy;
  - 2) At the option of SYC, the vessel may be "locked" in place by cable, chain or other method reasonably available to maintain custody of the vessel until the SYC Board of Directors releases the vessel to the Member;
- c. SYC may exercise any other rights SYC and its Board of Directors shall have at law, in admiralty or equity, including, but not limited to, arresting the vessel, placing a lien upon the vessel for the amounts owed (including accrued interest) and/or civil suit;
  - 1) Member agrees that any state civil suit shall be instigated and litigated in the County of Yolo, State of California;
  - 2) Member further agrees that any federal law suit shall be instigated and litigated in the Eastern District of California;
- d. SYC may seek in any combination of the above remedies.

6. Member shall pay and discharge all costs, expenses, and attorney's fees, which may be incurred by SYC in enforcing the provision of these Marina Rules, including but not limited to collecting any Delinquent slip rental and/or utility payments due under this Agreement and enforcing the termination provisions and any maritime or other liens.

7. Member shall not use the Mooring Space, or any part thereof or permit the same to be used for any illegal, immoral or improper purposes. Member shall not make or permit to be made any disturbance, noise or annoyance whatsoever detrimental to the vicinity of the Mooring Space. Member shall make any and all repairs to the Mooring Space if the damage was in any way caused by the fault or negligence of the boat or his guests, invitees or licensees and Member shall, at the expiration of the term of this Agreement, surrender and

deliver said Mooring Space, without demand in as good order and conditions as when entered upon, ordinary wear and tear excepted.

8. Member shall permit SYC or its agents, at any reasonable time, to enter the Mooring Space for the purpose of exhibiting same, dredging or making repairs thereto.

9. Member shall not assign this Agreement, nor sublet the Mooring Space, or any part thereof, to be used for any other purpose than as above stipulated, nor make any alterations therein, nor any and all additions thereto, without the prior written consent of SYC and remain upon the Mooring Space as a part thereof, and be surrendered with the Mooring Space at the termination of this agreement.

10. Member shall, at Member's sole cost and expense, comply with all statutes, ordinances, rules, orders, regulations and requirements of federal, state and municipal authorities of any kind and all of their departments and bureaus applicable to the Mooring Space and/or Member's rental thereof.

11. The Failure of SYC to enforce any provisions of this Agreement shall not constitute waiver of the right to enforce same thereafter.

12. Member agrees to maintain at least \$300,000 liability insurance on the above identified vessel, including dinghies, inflatable boats and auxiliaries, skiffs, and tenders. Member also agrees to add SYC as the "additional insured marina endorsement" and direct the insurance company to provide notification to SYC of all renewal, non-renewal or cancellation of the insurance policy. Member shall provide SYC, at time of signing this agreement, a copy of their current liability insurance and vessel registration. If coverage is inadequate at the time Member signs this agreement, Member shall provide proof of adequate insurance in compliance with this agreement within 30 days of signing this agreement.
