*Well check must be completed within 72 business hours of pick up from breeder. If a life threatening issue is found at the visit, the buyer can return the puppy within 1 week of pick up at the buyers expense. Breeder has the option of requesting a second opinion before issuing a refund. The returned puppy will be tested for Parvo before a refund is issued. In the event the puppy contracted Parvo, the refund is void. Parasites are not covered and buyer is responsible to continue with any de-worming that needs to be done, at the buyer's expense. There is no reimbursement for expenses incurred on a returned puppy.

*If using the potty training program, arrangements can be made for the puppy to have his/her well check before leaving for Tina's, at buyer's expense.

*We guarantee hips and eyes for 24 months of age. In the event of Hip Dysplasia, an x-ray must be sent to OFA or Pennhip for the rating of the hips. In the case of HD, we will reimburse the buyer up to the price of the puppy for surgery preformed for the HD. Receipts must be sent to the breeder when the surgery is preformed. Breeder will not reimburse the price of the x-rays. The breeder has the right to request a 2nd x-ray with the vet of breeder's choice, at the breeders expense. All reports must be sent to the Breeder.

*In the event of a genetic eye defect causing blindness, the eyes must be examined by an Ophthalmologist and the report sent to the Breeder. In the event of blindness, the breeder will reimburse the price of the puppy.

*Reimbursements do not include shipping expenses that are incurred to receive or return the puppy.

*Breeder is not responsible for any damage done to persons or property by the dog/puppy purchased from The Paw Pad Goldendoodles, Inc.

*Breeder is not responsible for behavior issues with the puppy. If the puppy is having behavior issues, the purchaser agrees to seek professional help.

*The Breeder will accept a puppy back, due to behavior, with no reimbursement to buyer of any kind.

*The puppy/dog does not come with breeding rights and must be spayed/neutered by the age of 6 months. Failure to alter the puppy by 6 months will void the health guarantee and the breeder can also choose to sue the buyer for \$3000. All legal actions will take place in Tazewell County, IL.. Buyer will be responsible for all court costs.
