



NEW YORK STATE BOATING SAFETY CERTIFICATE

Optional Credentialing of your DMV Document

Each person that successfully completed the New York Safe Boating Course since 2000 has received a Boating Safety Certificate, issued by New York State Parks.

You now have the option of noting on your NYS Driver License, Learner Permit, or Non-Driver Photo ID Card, issued by the New York State Department of Motor Vehicles, that you have earned the New York Safe Boating Certificate. For persons required to carry their Safe Boating Certificate when operating a motorboat or personal watercraft, the DMV-issued document satisfies the requirement that the operator has received a safe boating certificate.

If you want to have it noted on your NYS Driver License, Learner Permit, or Non-Driver Photo ID that you earned the NYS Safe Boating Certificate please follow these directions.

1. Check this box: ___ Yes, I would like my valid DMV-issued Driver License, Learner Permit, or Non-Driver Photo ID to note that I have earned a NYS Boating Safety Certificate.

2. Enter your valid NYS Department of Motor Vehicles ID number in the box below. Your DMV ID number is printed on the front of your NYS Driver License, Learner Permit, or Non-Driver Photo ID card.

3. Enter your New York Safe Boating Certificate number found in the upper right hand corner of the certificate in the box below.

4. Check this box: ___ Yes, I would like to immediately receive a new copy of my NYS Driver License, Learner Permit, or Non-Driver Photo ID, noting I have received a Boating Safety Certificate. **I understand that I am required to pay a license amendment fee of \$12.50 (\$5.00 for a Non-Driver Photo ID).**

The additional \$12.50 or \$5.00 charge is for the cost of producing and mailing a new DMV document to you. If you opt for this endorsement on your NYS Driver License or Learner Permit you must remit one check for \$12.50, in the case of a Non-Driver Photo ID you must remit \$5.00 payable to:

Check this box: ___ Yes, I would like to note on my Driver License, Learner Permit, or Non-Driver Photo ID that I have completed the New York Safe Boating Course, but I am willing to wait until the next regular DMV renewal (currently Driver Licenses are renewed every eight years).

If you choose this option, simply enter your DMV ID number and Boating Safety Certificate number in the boxes above, and your next regularly issued DMV document will note that you have earned the NYS Boating Safety Certificate. **There is no fee if this option is selected.**
