- LJD 2018 - July 20, 21, & 22
- Food Vendor Applications/fees/etc - due by June 1, 2018
- Set up July 19th
- Tear down July 22nd

Green - Recycling & Compostables

Lumberjack Days will be Green by 2022. Therefore, **all** packaging and food containers distributed will need to be either recyclable or compostable **by 2022**.

Starting with LJD 2018 we are working with Washington County to facilitate access to compostables for your food items. Information on their programs is attached and it is available at our web site. **You will need** to reach out to them **directly** to learn about what programs are available for compostable containers. At LJD we will provide recycle areas that support the sorting of trash, recycle, and compostables.

Based on input from many of you and last year's event we have made a few changes/additions:

Hours - Food vendor hours have been extended to 10:00PM on both Friday and Saturday.

Application Forms - This year applications should be **submitted via email**. Paper copies are not necessary or required. Checks are to be sent via mail. Remember your application is NOT complete until you have submitted **ALL** necessary forms and paid the appropriate fees. Please submit all forms at the same time/together to save us all some time.

Exclusive menu items - in the past this has been informally handled. The 2018 LJD application form allows you to select **up to 3** prioritized items that you would like as exclusive menu items. This is not a guarantee; The Locals will take your input and make a determination based on your request. For exclusive item consideration you must have **completed** the application process by the due date. Part of the consideration will be your past participation in LJD festivals. Exclusives notification will be made soon after the June 1 application deadline.

Electricity/power - at LJD portable generators are **not allowed**. The Locals will provide power based on availability and first requested (complete applications/fees/etc...). Please note that 120v/50a is very limited in Lowell Park. To use electricity, you **MUST** apply and include the cost in your application fees.

Booth space/size/fee - This year we are providing **three** sizes of booth spaces with corresponding fees. You need to select the correct space to fit your booth. We will provide spacing between the booths as required by fire code. If you do not fit into one of these three booth sizes, contact The Locals for a custom booth space & fee.

Optional Vendor Parking and product transport (*not finalized*) - we are working with an owner of a nearby lot for space that vendors can park and for transportation (including reasonable amount/size of product). If we are able to coordinate this there will be a fee to that group which potentially would be a charitable donation.

We will communicate with you as this develops or as things change.
