**Function:** Reporting to the Community Engagement Director, the Community Engagement Associate will provide administration, observation, and documentation support for CAASE¢s community engagement initiatives. The position primarily supports the developing Victims¢Rights Representation (VRR) Division of the CAASE Legal Department, ensuring that this division is accountable to and engaged with communities in south Chicago and Southern Cook County.

## **Victim's Rights Representation**

Facilitate community education on victimsørights in under-resourced neighborhoods on the south side of Chicago and in southern Cook County.

Develop data collection and analysis models to determine victims@rights representation needs on the south side of Chicago and in southern Cook County.

Identify and engage community partners in south Chicago and southern Cook County suburbs to determine victimsørights representation needs.

#### **Community Engagement and Organizing**

Support community engagement initiatives, including Survivor Advisory Councils, open mics, writing workshops and additional programming via facilitation, administration, documentation and social media communication.

Support Community Engagement Director in identifying and developing opportunities for survivors and survivor-leaders to influence and/or lead initiatives.

Other duties as assigned.

## **Experience and Qualifications**

Applicants must have:

experience working across communities most vulnerable to sexual exploitation, including communities of color, LGBTQ communities, undocumented people, those living with disabilities, those living under the poverty line and/or those with housing insecurity.

working knowledge of south side communities and organizations, especially organizations with a focus on preventing or treating sexual harm

experience with data collection/analysis

experience with program facilitation, administration, documentation and social media communication

experience with community organizing, political organizing and/or journalism

### The ideal applicant will also have:

comfort with/enthusiasm for public speaking

experience with digital technology, which may include audio and video recording, editing and/or engineering, photography and/or graphic design

a basic working knowledge of gender-based violence passion for advocacy and structural analysis proficiency in Spanish

Organization Values: CAASE is a feminist organization, committed to ending all forms of sexual exploitation including specifically sexual assault and prostitution. Funded by a cooperative agreement with the U.S. Department of Justice, Office of Justice Programs, Office for Victims of Crime (OVC), award number 2018-V3-GX-K018, the RISE Project is funding six legal Clinics to provide crime victims with access to legal representation to assert and seek enforcement of their rights throughout criminal justice processes, increase awareness of victimsørights and increase victim access to no cost legal services through an expanded body of attorneys knowledgeable about rights assertion and enforcement in criminal trial and appellate courts.
